

# **Negotiations Update:**

## **DBH** and Comp 13

DCNA is commencing a campaign against the Mayor. The Mayor has only offered a 3% raise in FY 2018, 2% in FY2019 and 3% in FY2020. The Mayor and the unions representing thousands of workers in Compensations Units 1 and 2 agreed upon the following annual salary raises: 3% in FY 2018; 2% in FY2019; 3% in FY2020; and 3.5% in FY2021. We have asked why the District will not provide DCNA with the 3.5% offer and it has not provided us

with an adequate reason. Noteworthy is the fact that some of these union employees work side by side with registered nurses in the Department of Behavioral Health, Child & Family Services Agency, Department on Disabilities, Department of Health and other DC Government agencies.

Additionally, in a time that the District has received a surplus of millions of dollars, the Mayor's refusal to provide the nurses with adequate raises of at least 3% annually is disappointing. Accordingly, we are going to Arbitration.

#### **Howard University/Howard University Hospital**

On April 2, 2018, Howard University/Howard University Hospital sent notification to DCNA of its desire to negotiate over the terms and conditions of the collective bargaining agreement. The agreement is set to expire on June 30, 2018. The parties have nearly reached agreement on the groundrules utilized in the bargaining process and expect to commence bargaining during the week of June 18. DCNA will be scheduling a union meeting in the very near future.

## DCNA Endorses Mr. Ben Jealous and Mr. Marc Elrich for Maryland Races



The District of Columbia Nurses Association (DCNA) announced today its endorsements of Mr. Ben Jealous for Governor of the State of Maryland (photo at left) and Mr. Marc Elrich for Montgomery County Executive (photo at right).

Edward J. Smith, Esq., Executive Director, DCNA, stated that "Mr. Jealous and Mr. Elrich have demonstrated a deep understanding of issues that affect nurses and health care professionals working in the DMV. Both candidates support Medicare for All, mandatory



nurse-patient staffing ratios and legislation designed to combat workplace violence in our hospitals."

Smith further advised that each candidate expressed commitment to ensuring that our elderly and our poor are not left behind while this region continues to grow.

DCNA's decision to endorse candidates in Maryland is unprecedented. DCNA believes that issues affecting nurses, health care professionals and residents in Maryland are similar to those affecting District of Columbia workers and residents. Additionally, a majority of DCNA's members live in Maryland. DCNA has also endorsed Marlin Jenkins, Gabriel Acevero and Walakewon Blegay for Maryland State Delegate positions.
