
# **DCNA Together – Making a Difference in DC**



### **GWU Hospital/Universal Health Services RNs Seek Union** with DCNA

On February 10th, registered nurses of The George Washington University Hospital (a subsidiary of UHS) announced their intent to form a union represented by DCNA. Quality patient care and nurse retention are at the forefront of this decision.

Nurse leaders stated:

We are driven by a desire to provide the safest, most compassionate and most patient-centered care possible. Unfortunately, repeated attempts to work personally and directly with hospital leadership have failed to yield lasting systemic improvements. The George Washington University Hospital is one of the prominent hospitals serving the DC community. We want to ensure that the hospital is a proper steward of the trust placed in them by the community, and treats patients with the dignity they deserve and staff with the respect we have earned.

Organizing with DCNA is the best way to achieve these goals, and we hope hospital administration will welcome this union as an opportunity to form a more constructive partnership with staff. This collaboration will lead to safer patient care by ensuring adequate staffing, in providing training programs, developing consistent policies, and increasing nurse retention.

We take our responsibility to our patients and their families seriously, and view unionizing as a community service that will better enable us to provide high-quality care to those we serve. We believe that great progress can be made by all of us working together as a team.

## **District of Columbia Government Nurses Finally Receive Raises and Bonus Payments**

The District Government, after a delay of 6 months, finally provided retroactive pay raises to nearly 300public sector nurses. In November, DCNA wrote the Mayor demanding payment; she never responded. DCNA received support from DC Council Chairman Phil Mendelson, who pressured the City Administer to implement the raise. Further, members contacted the office of the Mayor again demanding that the pay be made. Finally, DCNA filed a grievance and sought arbitration over the matter. Shortly after the arbitrators contacted DCNA and the Government, the District finally processed the payment. The mean retroactive payment was approximately \$ 8000.00.


