

Universal Health Services Implements Mass Layoffs at The George Washington University Hospital

Earlier this week, Universal Health Services laid off somewhere between 60 and 100 hospital employees, including several Clinical Supervisors, which DCNA argues are part of the bargaining unit. DCNA/GWUH nurses issued the following statement:

We are deeply saddened to have learned of the elimination of certain positions and subsequent firing and/or demotion of GWUH staff. There have been no announcements from our CEO or CNO and no word on plans. The lack of transparency and the manner of these terminations require response from management but that has not occurred. We continue to get information as time goes on. We encourage you to speak to your colleagues.

We are in the profession of caring and UHS has demonstrated that they are not. **Our patients and staff deserve better.**

DCNA has begun distribution of contract surveys to our members and is seeking volunteers to serve as members of the negotiations team, unit representatives and other roles. The current collective bargaining agreement expires on June 30, 2024.
