

DCNA Mourns the Death of AFL-CIO President Richard **Trumka**

(Excerpted from the AP) Richard Trumka, the powerful president of the AFL-CIO who rose from the coal mines of

Pennsylvania to preside over one of the largest labor organizations in the world, died Thursday (August 5). He was 72.

"The labor movement, the AFL-CIO and the nation lost a legend today," the AFL-CIO said, "Rich Trumka devoted his life to working people, from his early days as president of the United Mine Workers of America to his unparalleled leadership as the voice of America's labor movement." A burly man with thick eyebrows and a bushy mustache, Trumka was the son and grandson of coal miners. He was



born in 1949 in the small southwest Pennsylvania town of Nemacolin and worked for seven years in the mines before earning an accounting degree from Penn State and then a law degree from Villanova University.

At times, Trumka challenged blue-collar workers to confront their own prejudices, including a forceful denunciation of racism in the union ranks during Barack Obama's first campaign for the White House. "We can't tap dance around the fact that there's a lot of white folks out there ... and a lot of them are good union people, they just can't get past this idea that there's something wrong with voting for a Black man," he said during an impassioned 2008 speech. Until his death, he used his power to push for health care legislation, expanded workers' rights and infrastructure spending.

DCNA released a statement on Facebook – "Today is a very sad day for the labor movement, for workers across the world and for all who care about workers' rights and dignity. Mr. Trumka was a fine man and a tireless leader. Rest in power, brother."

Negotiations Updates

United Medical Center

On August 4th, DCNA leaders formally executed the recently negotiated collective bargaining agreement between DCNA and United Medical Center. The two most significant contract gains are the implementation of nurse to patient staffing ratios, believed to be the first in the DMV, and 15% salary increases between 2019 and 2023.

Howard University/Howard University Hospital

DCNA and HUH have agreed to extend the collective bargaining agreement for approximately 400 nurses and licensed health care professionals through August 31st. The parties have committed to bargaining sessions twice per week through August and are currently discussing matters relating to the working conditions of employees, including staffing, hours of work, subcontracting, grievance procedures and discipline. Despite the very real differences in proposals, Edward J. Smith, Chief Negotiator for DCNA, expressed confidence that DCNA will be successful in negotiating a fair and equitable contract on behalf of all members and one that will provide the opportunity for continuing excellent health care for DC residents.

Organizing Updates

DCNA is committed to organizing and adding new members to our union. Over the past several months, staff and leadership have signed up new members at United Medical Center and Children's National Hospital. We have signed up 53 new members at UMC since the Spring. DCNA is also having discussions with health care professionals working in facilities that do not have a union.

The Practice of Nursing – Deborah Thomas , RN, BSN, CDES

Most of all take good care of yourself, because we as one of the most sacred and respected professions, are needed now, more than ever.
